Children, youth and families come to our programs from all walks of life but each have one thing in common, they believe mentorship matters.

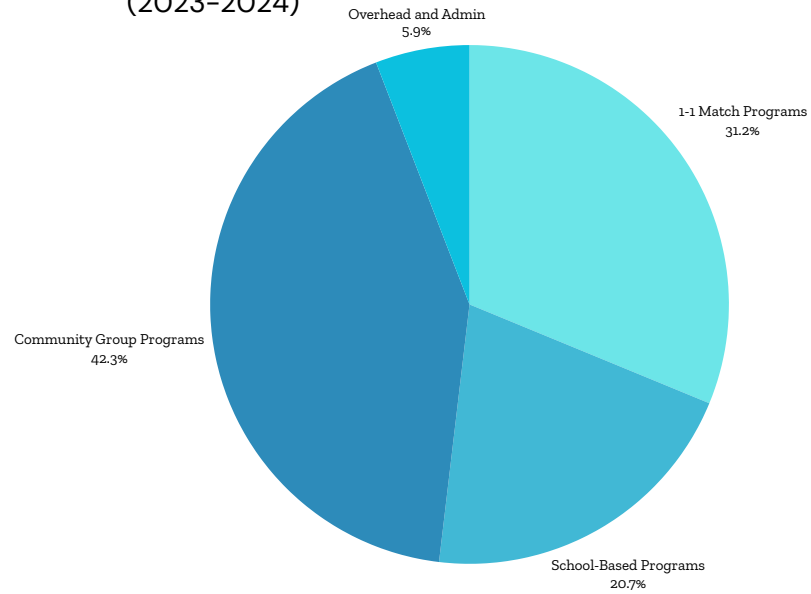
WHAT

From our one-to-one to our school and community-based group services, our mentorship programs support healthy development while combatting adverse childhood experiences.

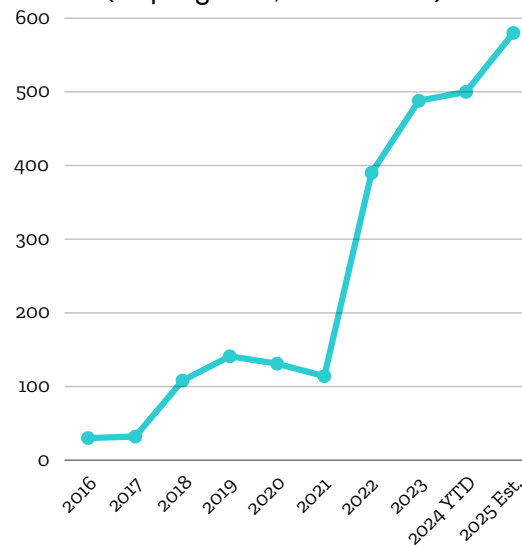
WHY
